## Update:

### Who will Defend Taxpayers' Interests in Indiana?

WASHINGTON, D.C. – Americans for Tax Reform applauds the following candidates for signing the Taxpayer Protection Pledge. By signing the pledge, a candidate commits “to oppose and vote against any and all efforts to increase taxes.”

ATR asks all candidates for federal and state office to stand in solidarity with the taxpayers of their entire state, and district if applicable. President Bush has signed the Pledge, and in so doing he joins 46 U.S. senators, 222 members of the U.S. House of Representatives, six governors, six lieutenant governors, two attorneys general, three secretaries of state, two treasurers, and more than 1280 state legislators.
